IMPORTANT MESSAGE

AF Form 1846 - Effective 5 March 2001, AFDPO will implement new procedures and update the existing ones for processing the AF form 1846, Request for and Record of Organizational Account. This initiative is to continue the effort of developing and improving the process of ordering controlled products (accountable, safeguard, classified, and FOUO).

We will begin this initiative by verifying the approving official's signature against the name provided by the MAJCOM publishing manager. If the signature on the AF form 1846 is not the same as the one provided by the MAJCOM, that AF 1846 will be disapproved. In addition, if a contractor facility has a need for controlled items, the Administrative Contracting officer in lieu of a publishing manager **MUST** sign the AF 1846 form.

The AF form 1846 is used to establish an organizational account for controlled items. Therefore, all AF 1846 forms submitted **MUST** contain organizational e-mail addresses. Those AF 1846 request received without organizational e-mail addresses (such as personal e-mail addresses) will be disapproved.

When submitting revised AF 1846s, please include your organizational account number on the form. If this number is not on the form, it will delay processing your request. Revised AF 1846 request will be processed in 5 working days. The word "Revised" must be placed in the "Remarks" section of the form.

The final step of this improvement process will be to scrub the existing 1846 organizational accounts. Beginning 5 March, AFDPO/PPL will begin scrubbing all existing 1846 accounts; checking for duplicity as well those organizations having numerous accounts. If duplicates are found, the accounts will be deleted and the customer notified. Customers with existing accounts that have personal e-mail addresses on their accounts will have to resubmit a revised AF form 1846. The organizational account number and organizational e-mail address **must** be on this revised form.
