This directive states the mission, defines the command structure, and establishes the responsibilities of the Air Force Intelligence Analysis Agency (AFIAA).

1. Mission . The Air Force Intelligence Analysis Agency (AFIAA) produces substantive intelligence for Secretary of the Air Force, Chief of Staff of the Air Force, and HQ USAF staff elements. It represents the Director of Intelligence, Surveillance and Reconnaissance (AF/XOI) on Department of Defense, Joint, and Director of Central Intelligence committees and National Intelligence Estimate panels. It prepares General Military Intelligence documents for use by deployed air and joint forces, and it tailors intelligence in support of Air Force force protection and weapon system acquisition programs. AFIAA also maintains HQ USAF Special Compartmented Intelligence local area network components. AFIAA is a field operating agency of Headquarters, United States Air Force.

2. Command . The Director, AFIAA:

- 2.1. Reports to, and operates under policies prescribed by, the Director, Intelligence, Surveillance and Reconnaissance (HQ USAF/XOI).
- 2.2. Manages personnel and other resources assigned to AFIAA.
- 2.3. Is dual-hatted as the Deputy Director for Intelligence Analysis, HQ USAF/XOIA.
- 2.4. Is authorized direct communication with Intelligence Community agencies and principals in support of national intelligence production.

3. Responsibilities . AFIAA will:

- 3.1. Produce substantive intelligence for SECAF, CSAF, and HQ USAF staff elements.
- 3.2. Provide time-sensitive intelligence indication and warning (I&W) input in direct support of Joint Chiefs of Staff products.

- 3.3. Provide AF/XO intelligence response cell to the Air Force Operations Group during crisis and contingency operations.
- 3.4. Represent AF/XOI at Joint, DoD, and National Intelligence activities and in centers throughout the National Capital Region (NCR), including the National Military Joint Intelligence Center (NMJIC) and the Joint Intelligence Task Force for Counterterrorism (JITF-CT).
- 3.5. Represent AF/XOI on Joint, DoD, and National Intelligence committees and panels as required, to include participation in the development of National Intelligence Estimates.
- 3.6. Prepare General Military Intelligence documents in support of deployed forces.
- 3.7. Provide tailored intelligence to Secretariat and Air Staff customers in support of weapon system development and acquisition.
- 3.8. Equip, maintain and recapitalize HQ USAF Special Compartmented Information systems and architecture throughout the NCR IAW DoD Intelligence Information Systems (DoDIIS) policies.
