What's Changing?

- Master Catalog will be a data base of all Air Force Publishing indexes
- Product Announcements will announce changes to digital or physical inventories
- ETS will have repository of digital products from AF to base level
- AFPDC will have repository of physical products from AF to MAJCOM/DRU/FOA

FORM 1846

- The **Air Force Form 1846**, *Request for and Record of Organizational Account* has been revised to gather organizational strength and requirement data to establish an organization account for obtaining physical products from the Air Force Distribution Center (AFPDC). This form is available on the Air Force website. Every organization will need to complete this form to receive physical products from the AFPDC. There should be at least 18-20 organization accounts for each base (i.e. CC, DP, SG, CE, SV, and etc.) Further breakdowns will be at the discretion of the local Commanders/Directors. (Additional information is available at the bottom of the form).
- Completed AF1846s are due to the AFPDC no later than 29 July 1999. Form may be mailed to Air Force Publishing Distribution Center, Attn: Mr Dorsey, 2800 Eastern Boulevard, Baltimore, Maryland 21220-2898 or Faxed to the following number (410) 687-3799. Failure to receive the completed AF1846 will result in activities currently receiving publications and/or forms through the PDO system, in no receiving any further physical publications and/or forms, classified publications and safeguard or accountable forms, and will prevent them from receiving material issued on ratio basis.
- Organizational Accounts will be assigned beginning 1 August 1999, based on the submission of AF Form 1846s. Once the accounts are assigned and the organization notified, each organization may begin submitting requisitions and requirements directly to the AFPDC. There will be no on-line access until 1 October 1999, requests may be submitted by mail, E-mail or fax.
