**AFI 34-219, 9 Sep 98, is supplemented as follows:**

This supplement applies to anyone who uses, sells, or otherwise serves alcoholic beverages on property under the control of the USAF Academy. Violations of AFI 34-219, paragraph 1-1, may render the offender liable to prosecution. Violation of Chapters 1, 2, and 3 may render the offender subject to disciplinary action. Cadet Lounge has been changed to Hap's Place. Also, the Field House parking has been included in the facility list for sale and consumption on or off premises. A "I" indicates revised material since the last edition.

1.1.2. Only persons 21 years of age or older may purchase, possess (includes possession while traveling to and from authorized facilities in compliance with Colorado state law), and consume alcoholic beverages of any kind in accordance with **Attachment 2 (Added)** (Added-USAFA), this supplement. Cadets of any age or class are not allowed to possess or consume alcohol on the USAF Academy with limited exceptions as set forth in 34 Training Wing instructions (AFCW). Additionally, cadet candidates of any age are not allowed to possess or consume alcohol on the USAF Academy, with limited exceptions as set forth in HQ USAFA Preparatory School (HQ USAFA/PL) instructions.

1.5.2. Alcoholic beverages may be sold during normal operating hours approved by 10 ABW/CC.

2. (USAFA) The 10th Air Base Wing Commander (10 ABW/CC) is the approval authority for any extension of hours.

2.1. The activities, areas and facilities in which alcoholic and malt beverages may be sold, possessed, or consumed are listed in **Attachment 2 (Added)**. Sale, possession, or consumption of alcoholic or malt beverages in areas not reflected in **Attachment 2 (Added)** (Added-USAFA) are prohibited except with permission from the appropriate major element commander (e.g., 34th Training Wing Commander [34 TRW/CC], Athletics [HQ USAFA/AH], Dean of the Faculty [HQ USAFA/DF], etc.) and final approval from 10 ABW/CC. When the Air Force Academy Athletic Association wants to provide alcoholic beverage service for its events or activities, it will secure that service through 10 SVS from the Air Force Academy's Morale, Welfare, and Recreation Fund. In the case of the Blue and Silver Booster Club's pre- and

post-football game brunches and buffets in the Falcon Stadium Press Box area, the Academy Athletic Association may secure this service from a commercial source.
